Subject **Statement showing reasons for delay in submission of the Annual Report and Audited Accounts of National Anti Doping Agency (NADA) for the year 2024-2025**

As per rule 20 of the Rules of National Anti Doping Agency, the Annual Report and Audited Accounts along with the Audit Report thereon of NADA are required to be laid in both the Houses of Parliament.

2. Further, as per the existing instructions of the Department of Parliamentary Affairs, the Annual Report as well as the audited accounts of an autonomous body are required to be placed in the Parliament within nine months after the closing of accounting year. Accordingly, the Annual Report and Audited Accounts along with the audited report thereon of NADA for the year 2024-25 was to be laid in the Parliament. However on account of the reason mentioned below, it has not been possible to lay the said documents before the Parliament as under: -

(i) The National Anti-Doping Agency has forwarded the balance sheet to the office of DG of Audit (Central Expenditure)) on 31.12.2025 duly approved by the Governing Body of NADA for undertaking the statutory audit of NADA so that audited account/annual report may be placed before the Both Houses of the Parliament. It is to mention that due to non-receipt of UC/Expenditure statement of the event conducted during the financial year, the internal audit by the Chartered Accountant could not be completed in time, which led to delay in finalization of the balance sheet and thereafter forwarding the same to O/o CAG for undertaking the audit.

(ii) The Audit Team from the Office of DG of Audit conducted the statutory audit between 22.01.2026– 06.02.2026 and SAR received on 23.03.2026. Thereafter, presented the SAR report before the Governing Body of the NADA for approval along with the Annual Report for 2024-2025.

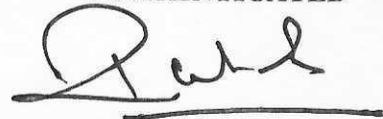
